### c. Automatically Collected Data

- Device and browser information.
- IP address and approximate location.
- Platform activity logs, primarily for security and to prevent fraud.



### 3. How We Use Your Information

We use the information we collect to:

- Enable connections and interactions between consultants and clients.
- Process payments and manage invoices safely.
- Maintain records of feedback and documentation.
- Ensure adherence to our platform's policies.
- Enhance our services and improve user experience.
- Send you important service announcements and legal notifications.

### 4. Who We Share Your Information With

We do **not** sell or rent your personal information to third parties for marketing purposes. Your data may be shared with:

- Payment Processors (e.g., Stripe, Paystack): For transactions and disbursements.
- Cloud Storage and Hosting Providers: To securely store your documents.
- Law Enforcement or Legal Authorities: When required by law or to enforce our policies.
- Our Internal Staff: For compliance review, quality control, and account approvals.

## 5. Consultant-Specific Notes

If you are a consultant, please note that your public profile—which includes your name, rating, specializations, and availability—is visible to other registered users. You are required to uphold professional confidentiality and protect the privacy of your clients. Storing or using client data outside of the Visalerate platform is strictly forbidden.

## 6. Data Security

We take robust technical and organizational steps to protect your data, including:

- SSL encryption to secure data transmission.
- Restricted access for staff and administrators.
- Encrypted payment channels through our trusted third-party processors.
- Server-side data validation and fraud detection tools.

While no method is completely secure, we are dedicated to protecting your information and minimizing risk.

### 7. Data Retention

We retain consultant profiles and related documents for the duration of the active account and for necessary compliance audits. Immigration materials from candidates are stored securely until their account is deleted or after a set retention period, such as three years. We use a limited number of cookies to manage user sessions, authenticate logins, and gather platform analytics. We do **not** use cookies for advertising or for tracking by third parties.
